Non-Standard 120 Acre Gas Proration Unit, Blinebry
Gas Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a non-standard 120 acre Blinebry gas proration unit covering the N/2 NW/4 and SW/4 NW/4 of Section 19, Township 22 South, Range 38 East, Lea County, New Mexico. This non-standard unit is to be attributed to the Gutman Well No. 2. In support of this application the following facts are submitted:

- (1) Applicant's Gutman Well No. 2 located 660 feet from the north line and 1980 feet from the west line of Section 19, is completed in the Blinebry Gas Pool and is assigned a 160 acre standard gas proration unit covering the NW/4.
- (2) Applicant's Gutman Well No. 3 located 2080 feet from the north line and 1980 feet from the west line of this Section 19, is being completed in the Blinebry Oil Pool.
- (3) The proposed non-standard gas proration unit consists of quarter-quarter sections within a single governmental quarter section.
- (4) The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2640 feet.
- (6) All Operators in the quarter section in which the proposed non-standard unit is located and within 1500 feet of the unit well have been furnished a copy of this application.

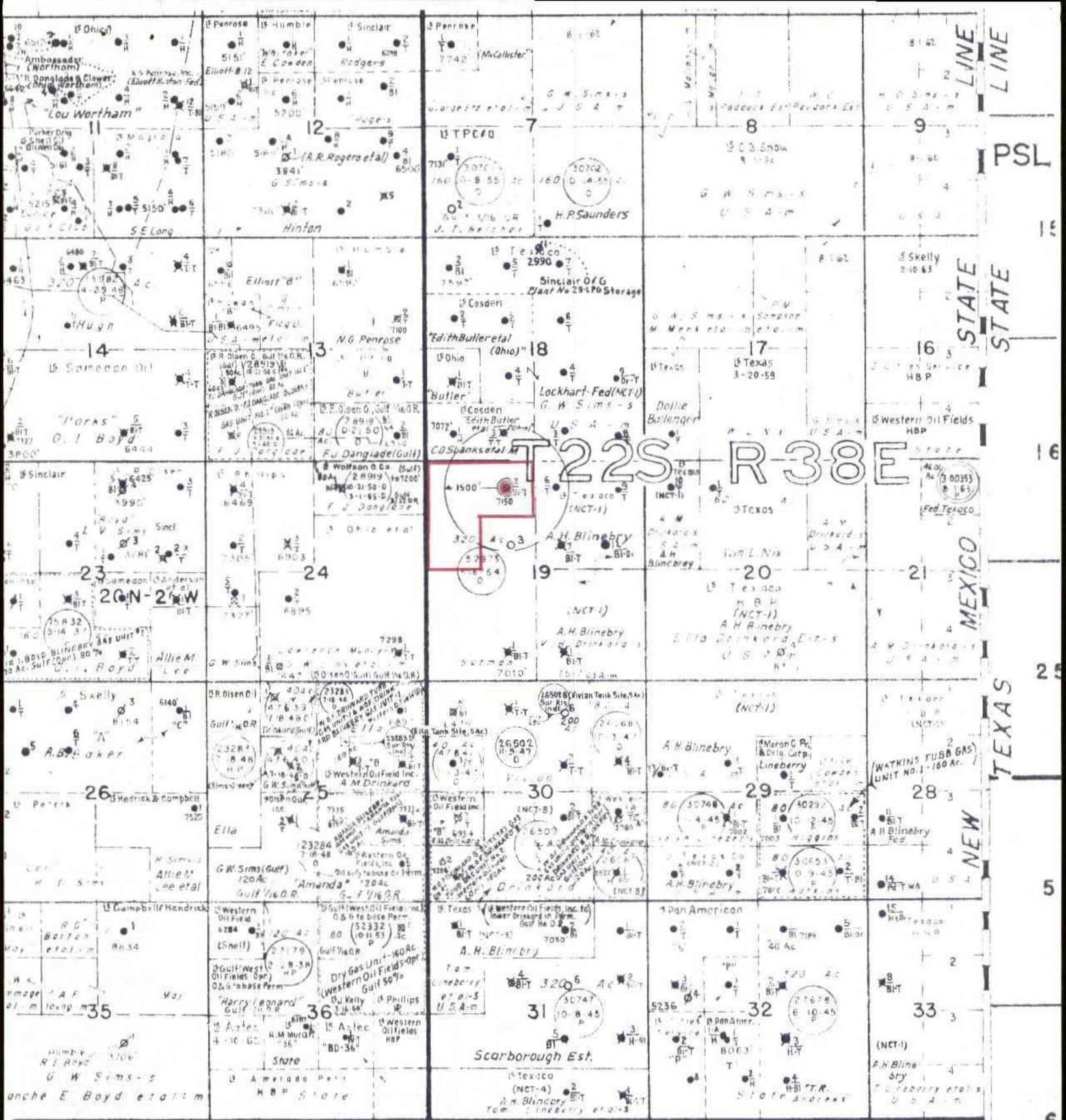
