
MORAN OIL PRODUCING & DRILLING CORPORATION HEREBY REQUESTS ADMINISTRATIVE APPROVAL OF A 40 ACRE NON-STANDARD PRORATION UNIT ON THE OWEN No. 2, 14-21-37, BLINEBRY GAS POOL, LEA COUNTY, NEW MEXICO. THIS APPLICATION WILL AMMEND OUR APPLICATION OF SEPTEMBER 27, 1962 REQUESTING A 120 ACRE NSP. THIS AMMENDED APPLICATION IS MADE FOR A REDUCTION OF THE PRESENT 160 ACRE UNIT TO A 40 ACRE UNIT. THIS REDUCTION HAS RESULTED FROM A BLINEBRY OIL COMPLETION BY SHELL ON ITS ANDREWS No. 2, NE/4 NW/4, 14-21-37 AND BY MORAN ON ITS OWEN No. 1, SW/4 NW/4, 14-21-37. SHELL IS PRESENTLY RECOMPLETING ITS ANDREWS No. 1, SE/4 NW/4 TO A BLINEBRY OIL COMPLETION AND AGREED TO APPLY TO DELETE THIS 40 ACRES FROM THE UNIT AT THIS TIME TO CUT DOWN THE CONFUSION AND PAPER WORK ON THIS GAS UNIT. THE MORAN OWEN No. 1 BLINEBRY OIL COMPLETION WAS EFFECTIVE AS OF OCT. 3, 1962 BY APPROVAL OF TRIPLE COMPLETION ORDER No. R-2322. THE ATTACHED FORM C-128 REFLECTS THE REQUESTED 40 ACRE NSP UNIT.

ALL OFFSET OPERATORS WITHIN 1500' OF THIS PROPOSED 40 ACRE NSP ARE BEING SENT A COPY OF THIS APPLICATION BY REGISTERED MAIL.

IF THERE ARE NO OBJECTIONS TO THIS APPLICATION BY OFFSET OPERATORS IN THE 30 DAY INTERIM YOUR IMMEDIATE APPROVAL WILL BE APPRECIATED.







Gentlemen:

We have your letter of September 27, 1962, requesting administrative approval of a 120-acre non-standard proration unit consisting of the S/2 NW/4, NW/4 NW/4 of Section 14, Township 21 South, Range 37 East, Lea County, New Mexico.

Please be advised that the Commission is unable to grant this application immediately as the General Rules and Regulations for Southeast New Mexico require the Commission to wait 30 days after all offset operators owning interests within 1500 feet of the well have been notified by registered mail of the intent to form the non-standard gas proration unit. The Commission therefore will temporarily assign an allowable for the oil well located in the NE/4 NW/4 of Section 14, and will grant the application if no objections are received from offset operators within the required 30-day waiting period.

Also please be advised that the Commission tentatively plans to make the non-standard proration order retroactive to the date the allowable was assigned to the oil well. It appears from your application that you have notified Shell Oil Company and The Atlantic Refining Company of the request for the above 120-acre non-standard gas proration unit;




