
Gentlemen:

Gulf Oil Corporation respectfully requests administrative approval of a non-standard 120-acre Blinebry Gas proration unit covering the S/2 SE/4 and NE/4 SE/4 of Section 32, Township 21 South, Range 37 East, Lea County, New Mexico. This non-standard unit is to be attributed to the W. T. McCormack Well No. 9. In support of this application, the following facts are submitted:

- (1) Applicant's W. T. McCormack Well No. 9, located 554 feet from the south line and 554 feet from the east line of Section 32 is completed in the Blinebry Gas Pool and is assigned a standard 160-acre gas proration unit covering the SE/4.
- (2) Applicant's W. T. McCormack Well No. 15, located 2,086 feet from the south line and 2,086 feet from the east line of this Section 32 has been recompleted in the Blinebry Oil Pool.
- (3) The proposed non-standard gas proration unit consists of contiguous quarter-quarter sections within a single governmental quarter section.
- (4) The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2,640 feet.
- (6) All Operators in the quarter section in which the proposed non-standard unit is located and within 1,500 feet of the Unit well have been furnished a copy of this application.
