Re: NSP-670 Reinstatement

Gentlemen:

Administrative Order NSP-670 approved an 80-acre non-standard gas proration unit consisting of the N/2 NW/4 of Section 35, Township 21 South, Range 37 East, in the Blinebry Gas Pool. The unit was dedicated to Continental's Lockhart A-35 Well No. 1 located in Unit D of said Section 35 and approval date was November 27, 1963. NSP-670 has been held in abeyance since Continental's Lockhart A-35 Well No. 3 was completed in Unit C of Section 35 in January, 1964, and the gas proration unit for Well No. 1 was reduced to 40 acres. Inasmuch as the Lockhart A-35 Well No. 3 is now shut-in and for such time as it remains shut-in in the Blinebry Gas Pool, Administrative Order NSP-670 is hereby reinstated.
