Gentlemen:

Reference is made to your application for approval of a 120-acre non-standard gas proration unit in the Blinebry Gas Pool consisting of the following acreage:

LEA COUNTY, NEW MEXICO  
TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM  
Section 35: N/2 NW/4 and SE/4 NW/4

It is understood that this unit is to be dedicated to your Lockhart B-35 Well No. 2, located 660 feet from the North line and 1980 feet from the East line of said Section 35.

By authority granted me under the provisions of Order No. R-1670, as amended, governing the Blinebry Gas Pool, you are hereby authorized to operate the above-described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with the pool rules, based upon the unit size of 120 acres.

The 120-acre non-standard proration unit approved by this order shall be reduced to an 80-acre non-standard proration unit effective the date an oil well allowable is assigned to the next oil well completed on the
