Re: Application for a Non-standard Gas Proration Unit to be assigned Sinclair's Jim Camp WN No. 2 in the Jalmat Pool, Lea County, New Mexico

Gentlemen:


Sinclair Oil & Gas Company wishes to make this application for an order under Rule R-520 which will establish a Non-standard Gas Proration Unit of 114 plus acres to be assigned to subject well.

In this connection Sinclair wishes to state:

1. Sinclair is the operator of the Jim Camp WN no. 2 which is located in Unit E of Section 6, T-24S, R-37E, Lea County, New Mexico.
2. The Non-standard Proration Unit Sinclair seeks to have assigned to subject well consists of Sinclair's Jim Camp WN lease which contains 114 plus acres and is located in W/2 SW/4 and SW/4 NW/4 of Section 6-24S-37E. Subject well is located 660 feet from north line and 660 feet from west line of this Unit. Subject well was originally drilled and completed in the Langlie-Mattix Pool on August 30, 1954. It is proposed that the subject well will be completed in the Jalmat Pool and the Langlie-Mattix zone will be plugged off.
3. The length or width of the proposed Unit does not exceed 5280 feet. Both the royalty and leasehold interests are common under this proposed Unit.
4. All the acreage within the proposed Unit may reasonably be presumed productive of gas.
5. The proposed Unit lies wholly within a single governmental section and consists of contiguous quarter-quarter-sections.
6. The proposed Unit is shown on the enclosed plat, and by copy of this letter of application all operators owning interests in this section and all operators within 1500 feet of the proposed unit are notified by certified mail of the intent of Sinclair to form the proposed Non-standard gas proration unit.

Sinclair, therefore, requests that the Secretary of the Commission approve the above described non-standard gas proration unit.




