Amended Administrative Order NSP-704

Dear Mr. Newell:


Reference is made to your application dated February 4, 1993 to reinstate the previously approved 114.22-acre, more or less, non-standard gas spacing and proration unit in the Jalmat Gas Pool (Division Administrative Order NSP-704, dated April 9, 1965) comprising Lots 5, 6 and 7 (SW/4 NW/4 and W/2 SW/4 equivalents) of Section 6, Township 24 South, Range 37 East, NMPM, Lea County.

It is our understanding that the original well dedicated to this unit, the Jim Camp "WN" Well No. 2 located 1980 feet from the North line and 660 feet from the West line (Unit E) of said Section 6, was abandoned in the Jalmat interval and recompleted as a single Langlie-Mattix oil producer in December, 1989.

Furthermore, it is our understanding that this unit will now be dedicated to ARCO's existing Jim Camp "WN" Well No. 3 located at a standard gas well location 1980 feet from the South line and 660 feet from the West line (Unit L) of said Section 6.

By the authority granted me under the provisions of Rule 2(a)4 of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, you are hereby authorized to continue operating the above-described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with Rule 5 of said pool rules based upon the unit size of 114 acres.

Dear Mr. Stogner:

ARCO Oil and Gas Company is writing to inform you that it intends to recomplete the Jim Camp WN Well #3 (located 1980' FSL and 660' FWL of Section 6, T-24S, R-37E, Lea County, New Mexico) into the Jalmat Gas Pool and produce it from an existing Jalmat gas proration unit, which consists of the SW/4 NW/4 and W/2 SW/4 of Section 6. This proration unit was approved by Division Order NSP 704 for the Jim Camp WN Well #2. The Jalmat zone of the Jim Camp WN Well #2 was abandoned in January 1990. The Jim Camp WN Well #3, which is scheduled for recompletion into the Jalmat Gas Pool from the Langlie Mattix Oil Pool, is in a standard location for this proration unit.


