Gentlemen:

Skelly Oil Company respectfully requests administrative approval of a Non-Standard 160-Acre, Todd-San Andres Gas Proration Unit covering the SW/4, Section 35, Township 7 South, Range 35 East, Roosevelt County, New Mexico. This Non-Standard Unit is to be dedicated to the Hobbs "V" Well No. 1, located 1980 feet from the South line and 1980 feet from the West line of Section 35. This will be an exception to Rule 4 (A), Order No. R-1670-G, Case 3298. In support of this application, the following facts are submitted:

- (1) The Non-Standard Unit consists of contiguous quarter-quarter sections or lots.
- (2) The Non-Standard Unit consists of 160 acres and lies wholly within a single governmental section.
- (3) The entire Non-Standard Unit may reasonably be presumed to be productive of gas from said pool.
- (4) All Operators within one mile radius of the proposed Non-Standard Unit have been furnished copies of this application by certified mail.
