Gentlemen:

Great Western Drilling Company has re-completed the H. Leonard "B" Lease, Well No. 2 as per request on Form C-101, April 29, 1966. Enclosed please find three C-104 Forms and three plats of the area.

Great Western Drilling Company requests 160 acre spacing on Well No. 2 due to its location, 660' from the north and west line of Section 32, 23-S, 37-E.

This will be a small producer. On a six hour stabilized test, 18/64" choke, the well produced 1,153 MCF with 440 psi on the tubing. Shut in tubing pressure is 640 psi.

This well was drilled as a Queen sand producer in 1939. During the past ten years it has produced a small quantity of gas only. The re-completion of the above data is from 2992 - 3109 feet (Yates - 7 Rivers).

The requested spacing is the west half of the north half of Section 32. All offset operators are being sent a copy of this letter.
