

Gentlemen:

Reference is made to your application dated August 29, 1966, for approval of a 360-acre non-standard gas proration unit consisting of the S/2 and SE/4 NW/4 of Section 18, Township 19 South, Range 32 East, NMPM, Lea County, New Mexico, to be dedicated to your Lusk Deep Unit Well No. 2.

Rule 4 of the Special Rules and Regulations governing the Lusk-Morrow Gas Pool, promulgated by Orders Nos. R-2373, R-2373-A, and R-2373-B, provides that all operators offsetting the proposed non-standard unit shall be notified of the application by registered or certified mail, and the application shall state that such notice has been furnished. We are enclosing, for your file, copies of Orders Nos. R-2373, R-2373-A, and R-2373-B.



Dear Mr. Porter:

Trebol Drilling Company, a Texas Corporation, qualified to do business in the State of New Mexico, has just acquired the interest of Southern New Mexico Oil Corporation in the LUSK DEEP UNIT, Lea County, New Mexico. We are making arrangements to produce three (3) Morrow gas wells in this unit which have heretofore been shut in. Trebol is a subsidiary of El Paso Products Company.

Trebol Drilling Company hereby respectfully requests approval of a non-standard gas proration unit for its Lusk Deep Unit #2 well located 660 feet from the South line and 1980 feet from the East line of Section 18, Township 19 South, Range 32 East, Lea County, New Mexico. The non-standard gas proration we are requesting for this well consists of the following described acreage:

T-19-S, R-32-E

Section 18: South half (S/2) and Southeast Northwest
Quarter (SE/4 NW/4) containing 360 acres in Lea
County, New Mexico

The remaining acreage in this section is outside the boundaries of the Lusk Deep Unit Agreement. We are working up a proposal to offer the Shell Oil Company and Pan American Petroleum Company who own the remaining acreage in this section a chance to participate in this well. If we are successful in our negotiations we will come back at such time and ask for a standard pro-ration unit. In the meantime, however, we would like to produce our well on a reduced allowable.
