Gentlemen:

Trebol Drilling Company, a Texas Corporation qualified to do business in the State of New Mexico and operator of the Lusk Deep Unit, hereby respectfully requests your administrative approval of a non-standard gas proration unit in the Lusk-Morrow Gas Pool consisting of the following described acreage in Lea County, New Mexico.

Township 19 South, Range 32 East

Section 29: North Half (N/2)  
Southeast Quarter (SE/4)  
West Half of the Southwest Quarter (W/2 SW/4)  
Containing 560 acres

Trebol Drilling Company is the owner and operator of the above described acreage. Texaco, Inc. is the owner of the East Half of the Southwest Quarter (E/2 SW/4). We had thought we were in agreement with Texaco, Inc. as to the operation of our Southern California Federal No. 1 well located 1980' from the

North line and 660' from the East line of the above Section 29 in the SE/4 NE/4. We have just recently filed with your Hobbs office C-102 forms on the above well dedicating all of Section 29 to this well. It now appears that we were a little premature in filing such C102 forms inasmuch as Texaco, Inc. and Trebol Drilling Company are not in agreement as to the ownership and operation of this Morrow gas well if all of Section 29 is dedicated to it. Therefore, we are filing this application for a non-standard gas proration unit consisting of the above described acreage. Ownership and operation of this well will be 100% in Trebol Drilling Company.


