
Getty Oil Company respectfully requests an exception to Rule 5-A of Order No. R-1670, for an approval of a 150 acre non-standard gas proration unit covering the E/2 of the NE/4, SW/4 of the NE/4, S/2 of the NW/4 of the NE/4, and NE/4 of the NW/4 of the NE/4 of Section 27, Township 12 South, Range 34 East, West Ranger Lake Devonian Gas Pool, Lea County, New Mexico. This non-standard unit will be attributed to Getty's State "BF" Lease, Well No. 3 located 1980' FNL and 990' FEL in Unit H of Section 27, T-12-S, R-34-E.

The following facts are submitted for your consideration:

1. The proposed non-standard proration unit consists of less acreage than a standard proration unit.
2. The non-standard gas proration unit consists of contiguous quarter-quarter sections.
3. The non-standard gas proration unit lies wholly within a single governmental section.
4. The entire non-standard gas proration unit may reasonably be presumed to be productive of gas from the West Ranger Lake Devonian Gas Pool as so stated in N.M.O.C.C. Order No. R-3480.
5. The length or width of the non-standard gas proration unit does not exceed 2640 feet.
6. All operators owning interests outside the non-standard gas proration unit but in the same section in which any part of the non-standard gas proration unit is situated, and all operators owning interests in acreage offsetting the non-standard gas proration unit have been furnished a copy of this application.




