Gentlemen:

In answer to your letter of June 27, 1969, and your advisement of the reclassification of Shell's Turner Nos. 5 and 6, we request that the Shell Turner No. 6 be included in a standard gas proration unit, Rule 5 (A), with Shell's Turner Nos. 12 and 13. This unit would no longer contain Shell Turner No. 3 and would consist of the entire SW/4 of Section 22. The 160-acre proposed gas proration unit is reasonably presumed to be productive of gas and would be produced from Well No. 13.

We further request that Shell Turner No. 3 be joined by the reclassified Shell Turner No. 5 to form a non-standard gas production unit as provided in Rule 29. This 80-acre proposed gas proration unit would be produced from Well No. 5.

We submit that the proposed units conform with the requirements of Order No. R-1670, and a plat is attached showing the proposed standard and non-standard units, the location of the Turner wells and other wells on the lease, as well as offset wells and ownership thereof.

It is respectfully requested that, until such units are formed, Shell Turner Wells Nos. 5 and 6 be allocated a gas allowable commensurate with the acreage contained in the unit formerly dedicated to the oil well in the Blinebry Oil Pool.

Gentlemen:

In response to your letter of July 8, 1969, it appears that you will have a standard gas proration unit of 160 acres comprising the SW/4 of the above-described Section 22 dedicated to your Shell Turner Well No. 13. All that is required in that case is for you to file a new plat with the Hobbs District Office.

In reference to the proposed 80-acre non-standard gas proration unit comprising the N/2 SE/4 of said Section 22, you must notify the Commission that all operators owning interests in Section 22 and all operators owning interests in acreage offsetting the proposed unit have been notified of the application. The Secretary-Director may approve the application if, after a period of 30 days following the mailing of said notice, no operator has objected.

The Shell Turner Wells Nos. 5 and 6 will receive 40-acre allowables until the above units are approved if you furnish the Hobbs Office of the Commission evidence that the wells have gas connections and are being separately metered.




Gentlemen:



Gentlemen:

We respectfully request that the attached waivers, executed by the only operators owning interest in Section 22 or owning interest in acreage offsetting the N/2 SE/4 of Section 22, be accepted by the Secretary-Director and the timely approval of an 80-acre non-standard gas proration unit comprising the N/2 SE/4 of Section 22, T-21-S, R-37-E, Lea County, New Mexico, in the Blinbry Gas Pool.

Shell Oil Company is the operator of the oil and gas rights under all but the NE/4 of Section 22, and of the SW/4 of Section 23. Gulf Oil Company is the operator of the NE/4 of Section 22, and Getty Oil Company is the operator of the NW/4 of Section 23, T-21-S, R-37-E, Lea County, New Mexico.

The proposed non-standard gas proration unit would be produced from Shell's Turner No. 5 and, for proration purposes, would be dedicated 80 acres comprising the N/2 SE/4 of Section 22, T-21-S, R-37-E, Lea County, New Mexico. A plat showing the proposed non-standard unit is attached.

Pursuant to paragraph four of your letter dated July 10, 1969, subject: "Standard and Non-Standard Gas Proration Units," Shell proposes to file with Oil Conservation Commission's Hobbs District office a new plat of the 160-acre standard gas proration unit consisting of the entire SW/4 of Section 22, T-21-S, R-37-E, Lea County, New Mexico, following approval of this request for a non-standard unit.
