Atlantic Richfield Company respectfully requests administrative approval under the provisions of Order No. R-1670, Rule 29, for an 80-acre pon-standard Blinebry Gas proration unit for the J. R. Cone "B" No. 2 well located 660' FSL and 1980' FWL of Section 26, T-21S, R-37E, and the J. R. Cone "B" No. I well, located 660' FSL and 1980' FWL of Section 26, T-218, R-37E. The proposed unit will comprise the SW/4, SE/4 and the SE/4 SW/4 of Section 26, as shown on the attached plat. We further request approval to produce the allowable for the proposed proration unit from either or both of the captioned wells in any proportion.

The J. R. Cone "B" No. 2 was reclassified from an oil to a gas well in the Blinebry Pool effective 12-1-70 because of a high gas-oil ratio. It was assigned a 40-acre non-standard gas proration unit consisting of the SW/4, SE/4 of Section 26, as of 5-19-71, by Administrative Order NSP-835 and has been producing as a non-marginal gas well. The Cone "B" No. 1 is presently an oil well in the Blinebry Oil Pool. Atlantic Richfield has been notified of a pending change in classification to gas well effective 1-1-72 because of a high gas-oil ratio under R-1670. rules 27 and 28. The "B" No. 1 is awaiting connection to the Northern Natural Gas gathering system.


