Dear Sirs:

Application is made herewith for an 80-acre non-standard gas proration unit in the Blinebry Gas Pool for J. R. CONE Eubanks Well No. 3. This Application is being made pursuant to recent reclassification by the Oil Conservation Commission of the subject well from the Blinebry Oil Pool to the Blinebry Gas Pool.

Involved in the Application also is the forty acres comprising Unit L of Section 14, T-21-S, R-37-E now dedicated in the Blinebry Oil Pool to J. R. CONE Eubanks Well No. 2. Inasmuch as Eubanks No. 2 also has been reclassified into the Blinebry Gas Pool by the Commission, it is planned to shut in the Blinebry zone in Well No. 2, request cancellation of the Blinebry Oil Pool acreage dedication to the well, and dedicate both Units K and L (80 acres, more or less) of Section 14 to the Blinebry Gas Pool in Well No. 3. The proposed 80-acre acreage dedication the Blinebry Gas Pool to Eubanks Well No. 3 is indicated on Oil Conservation Commission Form C-102 attached.

As required in Order No. R-1670, copies of this Application with attachments are being furnished by registered mail to all operators owning interests within 1500 feet of Eubanks Well No. 3. Waivers to this Application also are being requested of those operators.

For the information of all interested parties, the J. R. CONE Eubanks lease comprises the SW/4 of Section 14 (160 acres, more or less), T-21-S, R-37-E, Lea County, New Mexico.

Please advise if you desire any other information relative this Application.

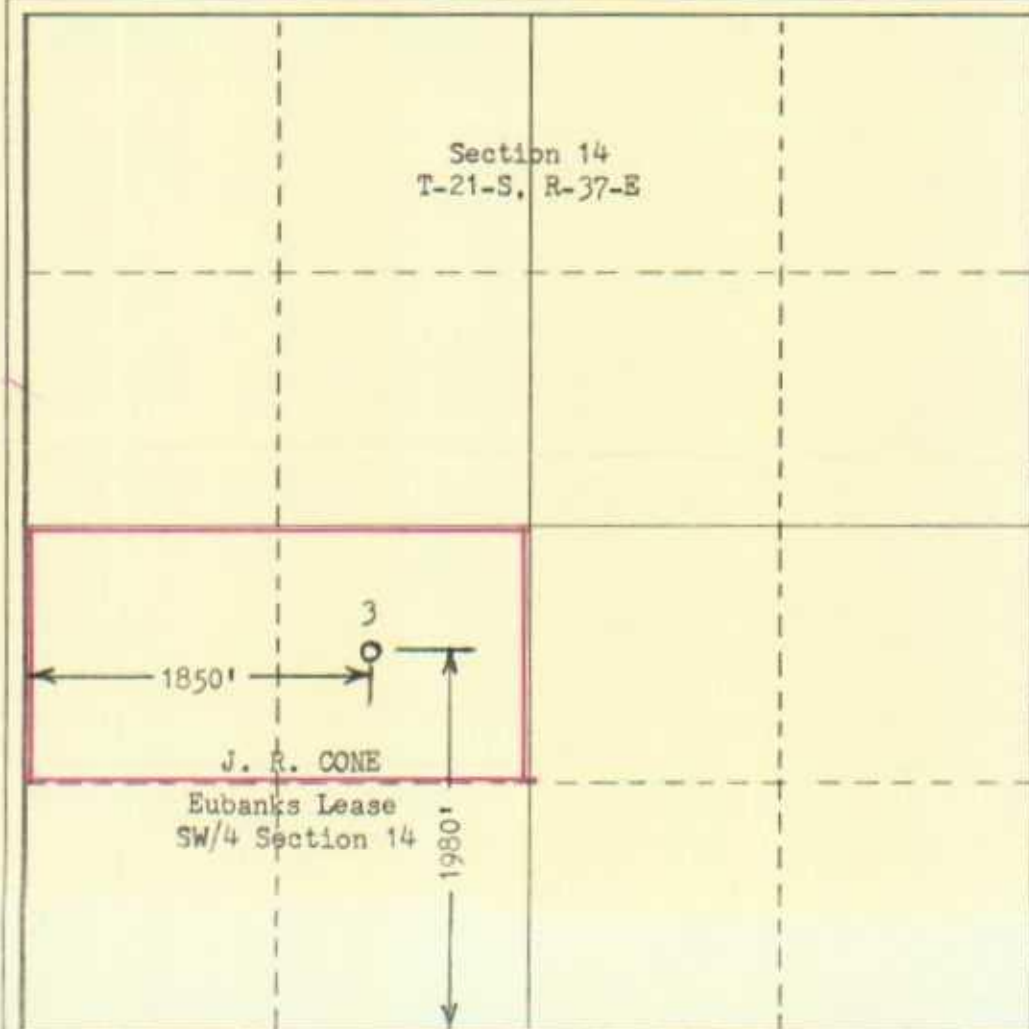

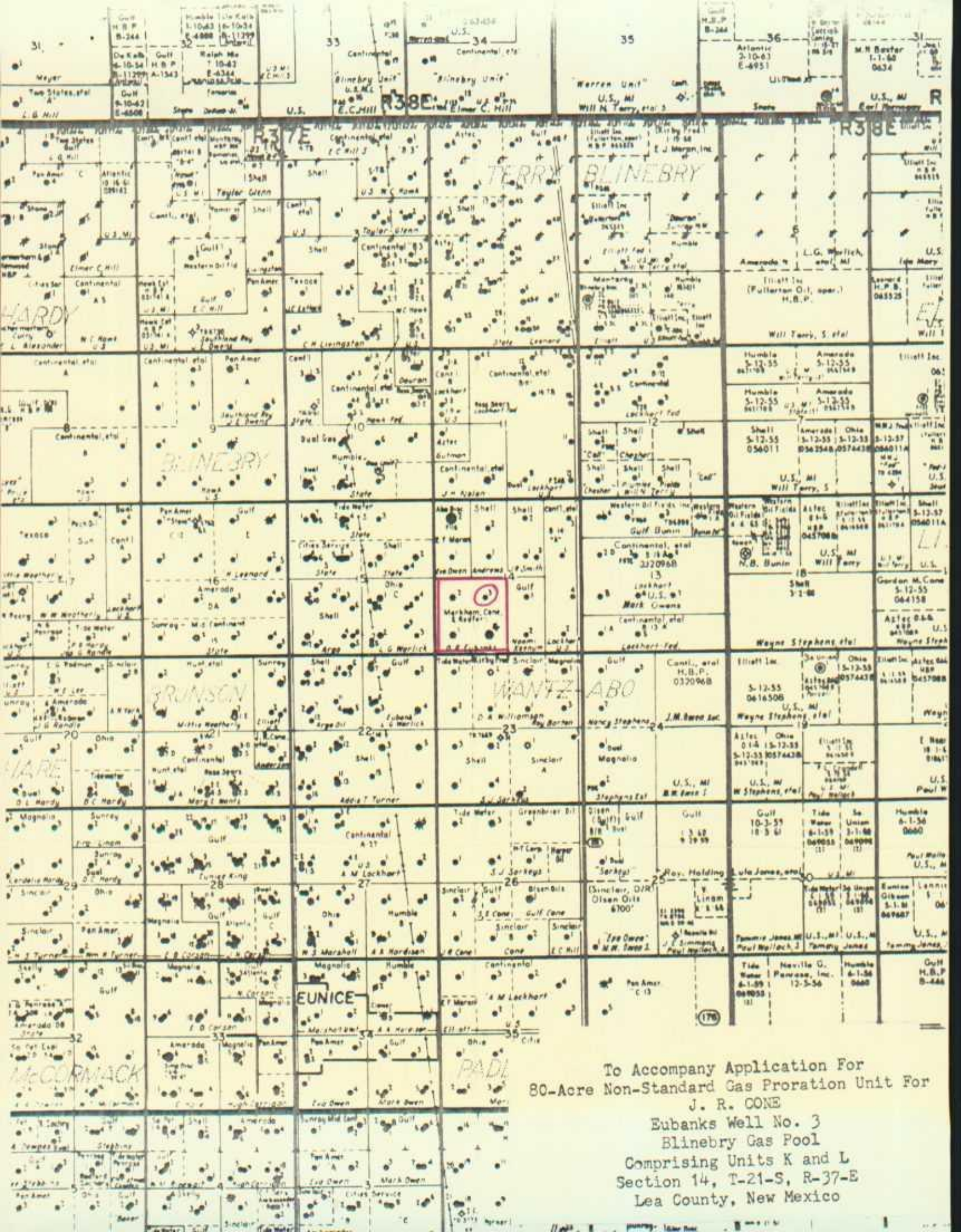
