Gentlemen:

Reference is made to your application for approval of a 120-acre non-standard gas proration unit in the Blinebry Gas Pool consisting of the following acreage:

LEA COUNTY, NEW MEXICO
TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM
Section 34: W/2 and SE/4 NE/4

It is understood that this unit is to be dedicated to your F. F. Hardison B Well No. 4, located 660 feet from the North line and 1980 feet from the East line of said Section 34.

By authority granted me under the provisions of Rule 5(C) of Order No. R-1670, as amended, you are hereby authorized to operate the above-described acreage as a non-standard gas proration unit.

Administrative Order NSP-834 is hereby superseded.
