Gulf Oil Corporation requests your administrative approval for a 40 acre non-standard proration unit in the Blinebry Gas Pool consisting of the NW/4 NW/4, Section 24, 21-S, 37-E, Lea County, New Mexico, to be dedicated to our Nancy Stephens No. 1, located 660' FN & WL, Section 24, 21-S, 37-E.

In support of this application the following facts are submitted:

1. Subject well was reclassified as a gas well in the Blinebry Gas Pool, due to Gas-Oil ratio in excess of 32,000/1, necessitating this non-standard unit.
2. There are no other wells producing from the Blinebry zone in the NW/4 NW/4 of this section.
3. The attached plat shows the proposed 40 acre non-standard unit outlined in red.
4. All offset operators have been furnished a copy of this application.


