Gentlemen:

Reference is made to Administrative Order NSP-927 which established a 40-acre non standard gas proration unit for the Sam D. Ares, Zattu Cushing No. 1, located 2310' from the North line and 1650' from the West line of Section 23. Permission was granted by Order No. R-5690 to convert the Zattu Cushing No. 1 to a water disposal well. This well is now shut-in waiting on tools and equipment to begin the necessary work to convert to water disposal status.

It is now respectfully requested that the 40-acre non-standard gas proration unit established for the Zattu Cushing No. 1 be transferred to the Zattu Cushing No. 2, located 2310' from the North line and 2310' from the West line of Section 23.







Dear Mr. Westbrook:

Reference is made to your letter dated October 3, 1994, as operator, Westbrook Oil Corporation is hereby authorized to simultaneously dedicate Jalmat Gas Pool production to the previously approved non-standard 40-acre gas spacing and proration unit ("GPU") comprising the SE/4 NW/4 (Unit F) of Section 23, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico (Division Administrative Order NSP-927, as amended) from the following two existing wells:

- the Zattu Cushing Well No. 1 (API No. 30-025-09606) located 2310 feet from the North line and 1650 feet from the West line of said Section 23; and,
- the Zattu Cushing Well No. 2 (API No. 30-025-25122) located 2310 feet from the North and West lines of said Section 23.

Furthermore, you are hereby permitted to produce the allowable assigned said non-standard 40-acre GPU from both the Zattu Cushing Well Nos. 1 and 2 in any proportion.
