Amended Administrative Order NSP-1031

Dear Mr. Vitrano:

Reference is made to your application of June 28, 1988 for two 160-acre non-standard gas spacing and proration units for the State "D" Well Nos. 3 and 6 located in Units A and F, respectively, of Section 32, Township 21 South, Range 36 East, Eumont Gas Pool, Lea County, New Mexico. In reviewing your application it was found that on September 29, 1976 the Division issued Administrative Order NSP-1031 which authorized two 160-acre non-standard gas spacing and proration units for the Eumont Gas Pool consisting of the NE/4 of said Section 32 to be dedicated to the State "D" Well No. 3 located 660 feet from the North and East lines (Unit A) of said Section 32 and the NW/4 of said Section 32 to be dedicated to the State "D" Well No. 5 located 660 feet from the North line and 1980 feet from the West line (Unit C) of said Section 32.

On September 1, 1977 the State "D" Well No. 5 was reclassified as an oil well and the dedicated acreage was reduced to 40 acres (RULE 2(a)2 of the Special Rules and Regulations for the Eumont Gas Pool as promulgated by Division Order No. R-8170, as amended.)

It appears at this time that the applicants State "D" Well No. 6 located at a standard gas well location 1980 feet from the North and West lines (Unit F) of said Section 32 is expected to be reclassified as a gas well.



Therefore, by authority granted me under the provisions of Rule 2(a)4 of said Order No. R-8170, as amended, Administrative Order NSP-1031 is hereby amended to reflect that the NW/4 of said Section 32, forming a non-standard 160-acre gas spacing and proration unit for the Eumont Gas Pool, is to be dedicated to said Well No. 6.

All other provisions of said Administrative Order No. NSP-1031 shall remain in full force and effect until further notice.
