

Atlantic Richfield Company respectfully requests administrative approval to form a 40-acre non-standard Blinebry gas proration unit consisting of the SE/4 of the SE/4 of Section 26, Township 21 South, Range 37 East, Lea County, New Mexico. This acreage will be dedicated to the E. C. Hill No. 1 which is located 660' from the south and east lines of Section 26. Presently, Well No. 1 is completed in the Blinebry oil zone. It has not produced since July 1975, and a recompletion attempt to the Blinebry gas zone is planned.

Atlantic Richfield Company believes approval of this request will protect correlative rights, promote conservation, and encourage the efficient recovery of gas reserves. Attached are an acreage dedication plat, a map of the area, and a list of offset operators who are being notified with a copy of this application.






