

Gentlemen:

Application is hereby made on behalf of Sidney Lanier for administrative approval of an 80-acre non-standard Jalmat Gas Proration Unit to comprise the W/2 NE/4 of Section 35, Township 24 South, Range 36 East to be dedicated to Ogg "A" No. 6 located 330 feet from North line and 1650 feet from East line of Section 35. Application is also made for approval of the unorthodox location of the Ogg "A" No. 6.

Remedial work performed on the subject well resulted in the production of gas only and the well has been reclassified as a gas well. Ogg "A" wells No. 1 and No. 2 located on the 80-acres are temporarily abandoned.

Attached is a plat showing the location of the Ogg "A" No. 6 and the offset operators. Offset operators have been furnished a copy of this application and plat by certified mail.
