

Gentlemen:

Marathon respectfully requests administrative approval of a 40-acre non-standard Blinebry gas proration unit for the Edith Butler "B" Well No. 2, located 1980' FSL and 2310' FEL, Section 13, Township 22-South, Range 37-East, Lea County, New Mexico. *Sec 13: NW/4 SE/4*

Edith Butler "B" No. 2 was originally planned to be a Wantz Granite Wash-Drinkard dual oil well. Testing of the Granite Wash proved noncommercial so the well was completed as a Blinebry-Drinkard dual oil well. Since the initial completion of the Blinebry (April 9, 1976) as an oil well, it was reclassified as a gas well and the oil allowable cancelled effective January 1, 1977.

Provisions of Commission Order No. R-1670-N state that in order to obtain a gas allowable, written consent in the form of waivers from the offset operators must accompany this request when submitted to the New Mexico Oil Conservation Commission. These signed waivers are attached with a map showing the location of the proposed 40-acre Blinebry gas unit.


