Application for NSP Unit, SEMU Eumont No. 98, 2310' FNL and 1980' FEL  
of Section 14, T-20S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval for a 120-acre non-standard gas proration unit for its SEMU Eumont No. 98, located in Unit G, Section 14, T-20S, R-37E, Lea County, New Mexico. Approval is requested under Rule R-1670 of the Special Rules and Regulations for the Eumont Gas Pool.

The proposed 120-acre unit will consist of the W/2 of the NE/4 and the NW/4 of the SE/4 of Section 14, T-20S, R-37E, Lea County, New Mexico. It will be necessary to modify two existing non-standard gas proration units to accomplish the dedication of this acreage to the proposed unit. These are the 240-acre gas units assigned for SEMU Eumont No. 66 and 92, approved under commission orders NSP-969 and NSP-971, respectively. The proposed revisions for these wells are as follows:

SEMU Eumont No. 66, located in Unit L, 1980' FSL and 660' FEL, a 200-acre NSP unit consisting of the SW/4 and the SW/4 of the SE/4 of Section 14, T-20S, R-37E.

SEMU Eumont No. 92, located in Unit C, 660' FNL and 1980' FWL, a 160-acre NSP consisting of ~~the W/2 and the NE/4~~ of the NW/4 of Section 14, T-20S, R-37E.

The proposed units conform to requirements in entirety as follows:

- 4) The length or width of said unit does not exceed 5,280 feet.
- 5) Copies of this application have been furnished by certified mail to all offset operators and all operators within said section.

Plats enclosed show the proposed units, the location of wells No. 66, 92 and 98 and offset ownerships. In compliance with regulatory procedures offset operators are being notified by copy of this letter.

It is respectfully requested that the Commission issue orders giving administrative approval to these NSP requests.


