Gentlemen:

Administrative Order NSP-1008 dated December 22, 1975 approved an 80-Acre Non-Standard Gas Proration Unit being SW/4, SE/4, and SE/4, SW/4 of Section 17, T-21-S, R-37-E, to be allocated to the Percy Hardy Well No. 2, (Unit O) and Well No. 3 (Unit N) located in Section 17, the allowable from which to be produced from any well in any proportion.




