Gentlemen:

Amoco Production Company respectfully requests administrative approval for a 160 acre non-standard proration unit for its Eva Owen "B" Well No. 5, located in Unit L, Section 34, T-21-S, R-37-E in Lea County, New Mexico. Approval is requested under Rule R-520 of the Special Rules and Regulations for the Eumont Gas Pool.

The proposed 160 acre unit will consist of the SW/4 of Section 34, T-21-S, R-37-E, Lea County, New Mexico. The proposed unit conforms to the following requirements:

- 1) Said unit consists of contiguous quarter-quarter sections.
- 2) Said unit lies wholly within a single governmental section.
- 3) The entire proposed unit may be reasonably presumed to be productive of gas.
- 4) The length and width of said unit does not exceed 5,280 feet.
- 5) All offset operators have been notified and requested to send signed waivers of objection to the N.M.O.C.C.


Enclosed is a plat showing location of well and offset operators. It is respectfully requested that the Commission issue orders giving administrative approval of this NSP request.
