Gentlemen:

Texaco Inc. respectfully requests administrative approval of a non-standard, 160 acre, Eumont gas proration unit for the New Mexico "E" State Well No. 2 in accordance with NMOCC Rule 104-D-II. The standard proration unit for the Eumont gas pool is 640 acres. The subject well is located 660' FSL and 1980' FWL of Section 1, T-20-S, R-36-E, Lea County, New Mexico, as indicated on the attached plat and Form C-102 (Well Location and Acreage Dedication Plat). The subject well was recently recompleted from the Monument Grayburg San Andres oil pool to the Eumont gas pool as a replacement well for the New Mexico "E" State Well No. 1, which was cement squeezed and abandoned in the Eumont because of casing leaks. The requested 160-acre unit was previously dedicated to Well No. 1.

Waivers of Protest for the nonstandard unit have been submitted to offset operators (see attached list) for their approval.
