Gentlemen:

Request for Non-Standard Acreage Dedication - Wantz No. 8-Unit O, Section 21, T-21S, R-37E, Lea County

Conoco Inc. respectfully requests the Wantz No. 8, Blinebry gas well, acreage dedication be changed from 160 acres to 120 acres. Currently Units J, N, O, and P of Section 21, T-21S, R-37E are dedicated to the subject well. Recently the Wantz No. 1, located in Unit N of the same section, was recompleted into the Blinebry zone. Since the No. 1 well is an oil well it should have 40 acres dedicated to it. We request the remaining 120 acres, Units J, O, and P of Section 21, T-21S, R-37E, become the pro-ration unit dedicated to Wantz No. 8.

Attached are a plat showing the dimensions of the proposed pro-ration unit and copies of letters to offset operators.



