Gentlemen:

Bliss Petroleum, Inc. recently drilled the Gulf Federal No. 1 well located 660' FNL & 1980' FWL in Section 26, T14S, R29E of Chaves County, New Mexico. We attempted a completion in the San Andres and Grayburg zones but was not successful. We then plugged back and completed the well in the Double L Queen gas pool through perforations at 1824' - 1836'. The AOF was 609 MCF/day. We then obtained a sublease agreement from Gulf Oil Exploration and Production Company covering the NW/4 of Section 26 from the surface to the base of the Queen formation. It is our understanding that the Standard Proration Unit for the Double L Queen Pool is 320 acres and we have only 160 acres to dedicate.

Bliss Petroleum, Inc. respectfully requests administrative approval of a Non-Standard Proration Unit for the 160 acres of the NW/4 of Section 26, T14S, R29E, Chaves County, New Mexico. In accordance to special rules and regulations set forth under order no. R5353 the following data is submitted with the request for a non-standard unit:

1. Copies of Form C-102 are attached.
2. A plat showing the existing offset wells producing from the Double L Queen Pool.
3. A list of all offset operators is attached. These operators have been sent a copy of this application by certified mail.




