Gentlemen:

Zia Energy, Inc. drilled a well on their Elliott "A" State lease which is the No. 1 well located 660' FSL and 1980' FEL of Sec. 27, T-20-S, R-36-E, a standard location. This well has been completed as a Eumont Gas Pool gas well from perforations in the Queen formation from 3612' to 3677'. The acreage required for a standard proration unit is 640 acres in the Eumont Gas Field. Therefore, you are requested to approve a 40 acre non-standard proration unit for this well, consisting of the SW/4-SE/4 of Sec. 27, T-20-S, R-36-E.

A copy of the C-102 (Well Location and Acreage Dedication Plat) is enclosed to show the location of the Elliott "A" State No. 1 and to indicate this acreage dedicated to this well.


