HNG Oil Company has applied for a permit to drill the Golden Lane "1" Federal, Well No. 1 in Eddy County, located 4720' FSL & 1650' FEL of Section 1, T21S, R28E. lots 1, 2, 7, 8, 9, 10, 15 and 16 dedication

Due to the oversized section, and in the event this well is a good producer, we plan to drill a second well on the 294.09 acres in the west half of Section 1, and possibly pool the remaining 160 acres in the south portion of our 748.4 acre lease with the 160 acres belonging to Texas Oil & Gas located in the south portion of the section.

In order to properly develop the field, this office is requesting administrative approval to drill a non-standard proration unit for Well No. 1 comprised of the 294.31 acres outlined on the attached plat.




