Letters are being set to all offset owners or operators.

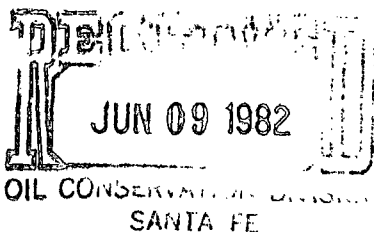

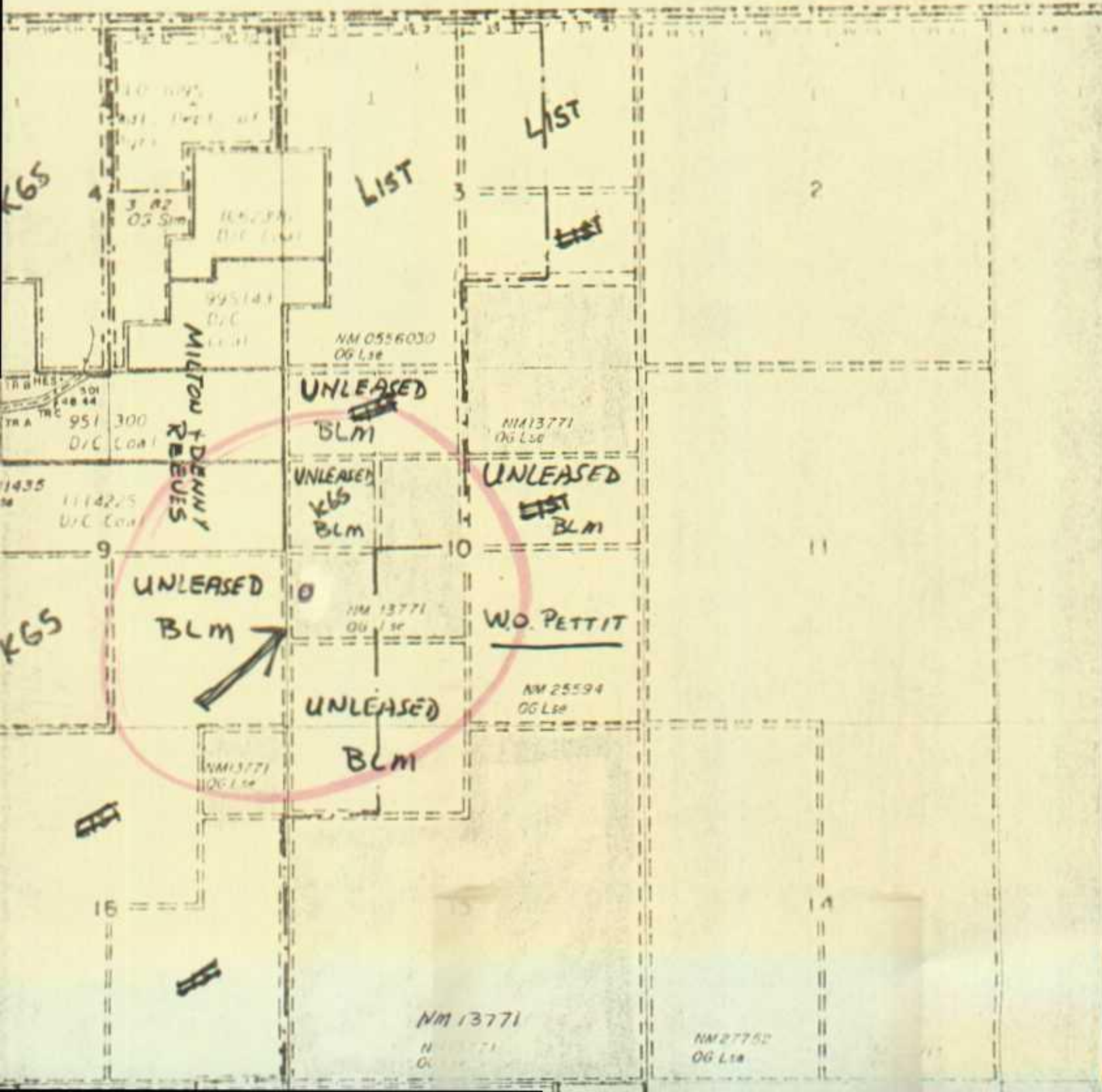
