



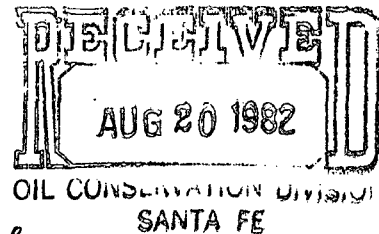

Gentlemen:

It is requested that two non-standard gas proration units and prorated gas allowances be granted and assigned to our D.A. Williamson, Wells No. 1 and 2.

D.A. Williamson Well No. 1, located in Unit D, Section 23, T-21S, R-37E was reclassified from oil to gas on 1-1-82 due to previously submitted GOR test on form C-116. This well was originally drilled as an oil well and is on an orthodox location of 660' FNL and 660' FWL. We respectfully request that a NSP of 40 acres be created and dedicated to this well. The NSP will consist of the NW/4 of the NW/4 of Section 23, Unit Letter D.

Additionally, our D.A. Williamson Well No. 2, located in Unit E, Section 23, T-21S, R-37E was reclassified from oil to gas also on 1-1-82 due to previously submitted GOR test on form C-116. This well was originally drilled as an oil well and is on an orthodox location of 1980' FNL and 660' FWL. We respectfully request that a NSP on 40 acres be created and dedicated to this well. The NSP will consist of the SW/4 of the NW/4 of Section 23, Unit Letter E.

Each of the proposed units will not conform to the regulatory requirement of 160 dedicated acres as stated in order No. R-1670N and it is therefore requested that a prorated allowable be granted. The entire proposed unit may be reasonably presumed to be productive of gas. Copies of this application have been furnished by Certified Mail to all offset operators and all operators within the section.

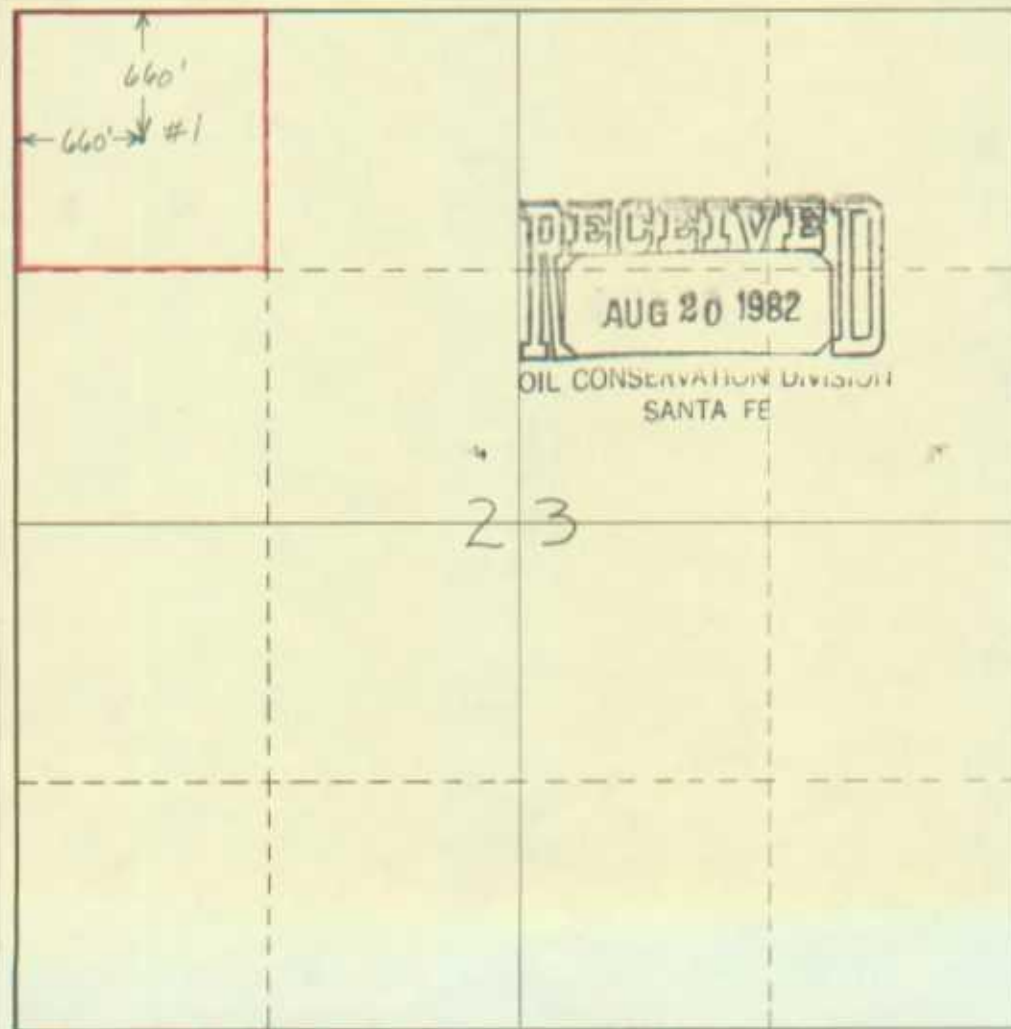

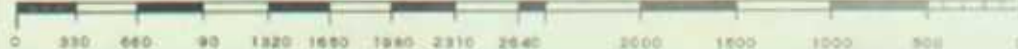

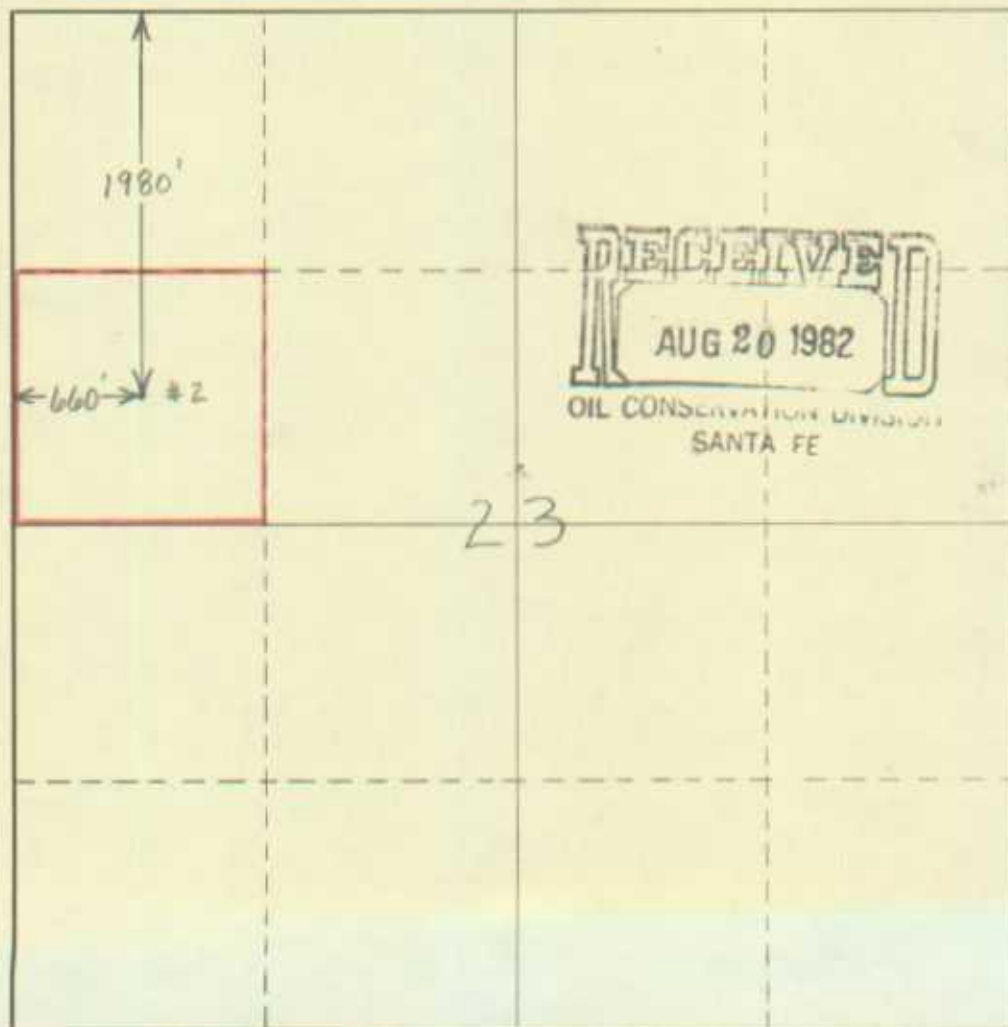
