Mesa Petroleum Co. hereby requests approval of a 41.02 acre Non-Standard West Knowles-Drinkard Oil Pool Proration Unit comprising all of lot 4 in Section 3, Township 17 South, Range 37 East, Lea County, New Mexico to be dedicated to Mesa's Meyers No. 1 well which is located 660' from the north line and 660' from the west line of the said Section 3.

In support of this application the following information is submitted:

1. This acreage is currently dedicated to the said Meyers No. 1 well which was originally plugged back to produce from the Paddock and which did not require a non-standard proration unit.
2. Said well was worked over, the Paddock formation was abandoned and the well was recompleted in the Drinkard formation. Attached please find copies of two Sundry Notices and one Request for Allowable to that effect.
3. A plat is attached showing the 41.02 acre unit in red.
4. Copies of this application have been furnished by certified mail to all operators offsetting the proposed non-standard unit.
