Gentlemen:

Mobil Producing TX. & N.M. Inc. (MPTM) is submitting a revised C-102 and requesting approval of a nonstandard acreage dedication of 192.36 acres for the subject well.

Well #1 was drilled and completed as an oil well on an acreage dedication of 192.36 acres. The well has since been reclassified as a gas well due to a high gas-oil ratio. The standard acreage dedication for a gas well is 320 acres. This nonstandard unit of 192.36 acres is necessitated by a variation in the legal subdivision.

Each offset operator on the attached list is being furnished a copy of this letter and attachment by certified mail as notice of this application and request for waiver.

MPTM is requesting that this application be approved administratively under Rule 104 D.II. If administrative approval is not granted, MPTM requests that this application be set for hearing at the earliest date possible.






