



Application for a Non-Standard Proration Unit *Gas*  
Jicarilla Tribal 396 Well No. 1  
Chacon Dakota Pool *Associated*  
Rio Arriba County, New Mexico

Amoco Production Company hereby makes application for a non-standard 160 acre proration unit, consisting of the NE/4 of Section 8-Township 23 North-Range 3 West, Rio Arriba County, for the Jicarilla Tribal 396 No. 1. The attached plat shows the proposed non-standard proration unit as well as offset ownership.

The Jicarilla Tribal 396 Well No. 1 was completed as an oil well in the Chacon Dakota pool on July 26, 1980 with a 160 acre dedication. The current GOR test shows that this well now has a GOR in excess of 30,000:1 and pursuant to the pool rules is now classified as a gas well requiring a 320 acre dedication.


Amoco is requesting a non-standard 160 acre proration unit due to the fact that both the SE/4 and the NW/4 of Section 8 have been dedicated to other wells. The SE/4 has been dedicated to the Jicarilla Tribal 396 No. 2. This well was completed on July 8, 1982, in the Dakota, and is currently shut in waiting on pipeline connection. The NW/4 has been dedicated to the Jicarilla 396 Well No. 3, which is currently waiting on completion tools. Although the ownership is common throughout Section 8, Amoco believes that it would be inappropriate to form a 320 acre proration unit until the true nature of production from these two new wells can be determined.






