

Northwest Pipeline Corporation requests permission to complete the Gallup formation in the above captioned well in an unorthodox location due to topography. This location was previously approved for the Dakota formation by Administrative Order NSL-1652 dated February 14, 1983.

The South half of Section 25 has been dedicated to the Gallup well. The South half consists of 270.04 acres and is Non-Standard due to a variation in the legal subdivision of the U.S. Public Land Survey. Northwest requests permission to produce the Gallup as a Non-Standard Gas Unit. A Non-Standard Gas Proration Unit was approved for the Dakota formation on September 28, 1983.

An application to commingle the Gallup and Dakota formations has previously been submitted for your consideration.
