Gentlemen:

Gulf Oil Corporation requests administrative approval for a 120-Acre Non-Standard Gas Proration Unit in the Blinebry Gas Pool, comprising the N/2 of NE/4 and SE/4 of NE/4 of Section 14-T22S-R37E, Lea County, New Mexico, to be assigned to Gulf's Hugh #6 well. In support thereof, Gulf Oil Corporation states the following facts:

1. The proposed Non-Standard Gas Proration Unit will meet the requirements of Rule 5(c) of the Oil Conservation Division Order No. R-1670 as follows:
 - a. The proposed Non-Standard 120-Acre Proration Unit consists of less acreage than a standard 160-acre proration unit.
 - b. The Non-Standard Gas 120-Acre Proration Unit consists of contiguous quarter-quarter sections.
 - c. The Non-Standard 120-Acre Proration Unit lies wholly within a single government section in the Blinebry Gas Pool with 160-acre standard proration units.
 - d. The entire Non-Standard 120-Acre Gas Proration Unit may be reasonably presumed to be productive of gas from the Blinebry Pool.
 - e. The length or width of the Non-Standard Gas Proration Unit does not exceed 5280 feet.
 - f. This letter will serve as notification to all operators owning interest in the section containing the proposed Non-Standard 120-Acre Proration Unit and all operators within 1500 feet of the Hugh #6 well.


