Gentlemen:

Gulf Oil Corporation requests administrative approval for an 80-Acre Non-Standard Gas Proration Unit in the Eumont Gas Pool, comprising the Center of NE/4 of NE/4 of Section 5-T22S-R37E, Lea County, New Mexico, to be assigned to Gulf's Stebbins "B" #1. In support thereof, Gulf Oil Corporation states the following facts:

**660' FNL AND 660' FEL OF SEC. 5**

1. The proposed Non-Standard Gas Proration Unit will meet the requirements of Rule 5(c) of the Oil Conservation Division Order No. R-1670 as follows:
  - a. The proposed Non-Standard 80-Acre Proration Unit consists of less acreage than a standard 640-Acre Proration Unit.
  - b. The Non-Standard Gas 80-Acre Proration Unit consists of contiguous quarter-quarter sections.
  - c. The Non-Standard 80-Acre Proration Unit lies wholly within a single government section in the Eumont Gas Pool with 640-Acre Standard Proration Units.
  - d. The entire Non-Standard 80-Acre Gas Proration Unit may be reasonably presumed to be productive of gas from the Eumont Pool.
  - e. The length or width of the Non-Standard Gas Proration Unit does not exceed 5280 feet.
  - f. This letter will serve as notification to all operators owning interest in the section containing the proposed Non-Standard 80-Acre Proration Unit and all operators within 1500 feet of the Stebbins "B" #1.


