

As I discussed with you earlier, the Tom L. Ingram No. 1 Federal "AR" was drilled and completed as an oil well at a location 1980' FSL & 660' FWL of Section 19, T-8-S, R-38-E, Roosevelt County, New Mexico. The location is in an undesignated area within one-half mile of San Andres (P-2) oil production in the Bluit San Andres Associated Pool. Field rules specify 80-acre proration units.

The balance of the acreage in the SW/4 of Section 19 is owned by Amoco and they declined to supply the additional acreage.

For this reason, it is requested that the Secretary-Director of the Commission grant an exception to the size requirements specified in Order No. R-5353 by the authority given in Rule 2 (c).

Copies of this request have been sent to the other three offset operators by certified mail requesting that they execute a waiver.


