Gentlemen:

Gulf Oil Corporation requests your administrative approval of a 40 acre non-standard proration unit in the Hobbs Drinkard Pool consisting of the SE/4 of the NE/4 of Section 33-18S-38E, Lea County, New Mexico, to be dedicated to our W. D. Grimes (NCT-B) No. 8, located in Unit H, 2115' FNL and 600' FEL of Section 33-18S-38E, Lea County, New Mexico.

In support of this application, the following facts are submitted:

1. W. D. Grimes (NCT-B) No. 9, 510' FNL 660' FEL Section 33-18S-38E, Lea County, New Mexico, was completed in the Hobbs Drinkard Pool with the N/2 of Section 33 dedicated to this well.
2. Our W. D. Grimes (NCT-B) Lease consists of the N/2 NE/4, SE/4 NE/4 and the NE/4 SE/4 of said Section 33 which will not allow dedication of 80 acres to both Well Nos. 8 and 9 as stipulated in the order governing the Hobbs Drinkard Pool.
3. There are no other wells producing from the Hobbs Drinkard zone in the SE/4 NE/4 of Section 33.
4. The attached plat and C-102 shows our W. D. Grimes B Lease outlined in red as well as the 40 acre non-standard proration unit to be dedicated to Well No. 8.

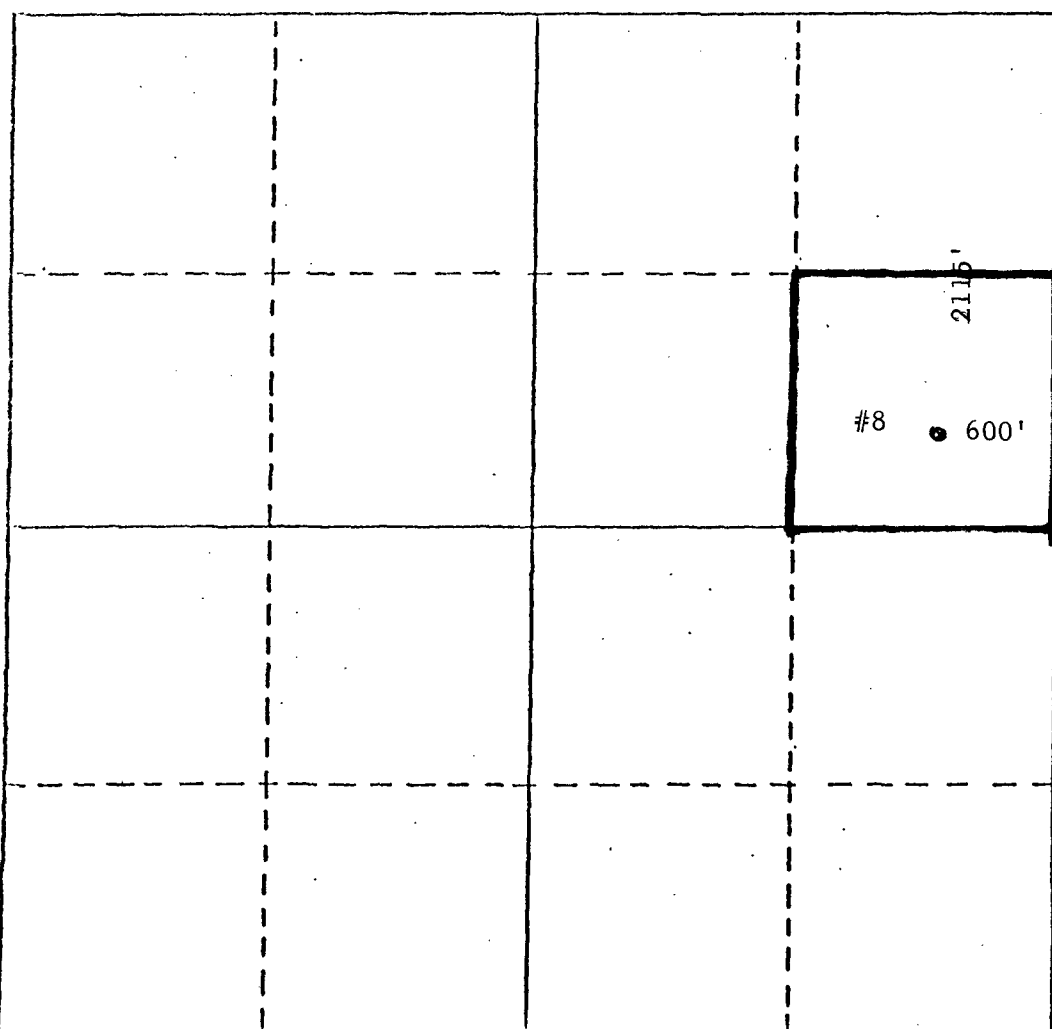
