



Ladies and Gentlemen:

Champlin Petroleum Company, with its partners Chorney Oil Company and Norcen Energy, Inc., plan to drill a 5120' Lower Gallup formation well in the SW/4NW/4 of Section 29, T25N, R11W, San Juan County, New Mexico.

Under Rule 2 of New Mexico State Order R-1069-D, the designated proration unit for the subject well would normally be the S/2NW/4 of Section 29, T25N, R11W; however, under Rule 4, the Secretary-Director of the Oil Conservation Commission may grant an exception to Rule 2 where no objection is filed by an operator within a 2640-foot radius of the well.

Champlin has requested that the Oil Conservation Commission assign a proration unit for the subject well as follows:

Township 25 North, Range 11 West
Section 29: W/2NW/4

San Juan County, New Mexico

Enclosed is a plat showing lease ownership within a 2640-foot radius of the proposed well location.


