ARCO Oil and Gas Company (AOGC) respectfully requests administrative approval for a 40-acre non-standard proration unit for the Lea 396 State No. 2, located SE/4 NW/4, Section 35, T-15-S, R-36-E, Lea County, New Mexico. This application is necessary due to offset development.

NMOCC Order No. R-892 established 80-acre proration units for the Dean Permo-Pennsylvanian Pool. However, Bliss Petroleum recently completed the ARCO State No. 1-Y as a Dean Permo-Pennsylvanian producer in the SW/4 NW/4, Section 35, T-15-S, R-36-E, Lea County, New Mexico. The ARCO State No. 1-Y is located on the western 40-acres of the original 80-acre proration unit occupied by AOGC's Lea 396 State No. 2. Bliss Petroleum has requested NMOCC approval for the formation of a 40-acre non-standard proration unit for the ARCO State No. 1-Y, which necessitates the formation of a 40-acre non-standard proration unit for the Lea 396 State No. 2. 


