Administrative Order NSP-1612-A

Dear Mr. Trautman:

By Division Administrative Order NSP-1612(SD)(NSL), as amended, Chevron was authorized a 120-acre non-standard gas spacing and proration unit (GPU) in the Blinebry Oil and Gas Pool comprising the N/2 NW/4 and SW/4 NW/4 of Section 28, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico. Blinebry gas production from said unit has until recently been simultaneously dedicated to the Eunice King Well No. 19 (API No. 30-025-06856), located at a standard gas well location 660 feet from the North line and 1980 feet from the West line (Unit C) of said Section 28 and to the Eunice King Well No. 24 (API No. 30-025-06864), located at an unorthodox gas well location 2086 feet from the North line and 760 feet from the West line (Unit E) of said Section 28.

Reference is made to your application dated October 11, 1994 to reduce said 120-acre GPU by deleting the 80 acres comprising the W/2 NWW/4 of said Section 28. It is our understanding that the NW/4 NW/4 (Unit D) of said Section 28 is to be utilized as a standard 40-acre "oil" spacing and proration unit in the Blinebry Oil and Gas Pool for the Eunice King Well No. 25 (API No. 30-025-06865) and the SW/4 NW/4 (Unit E) of said Section 28 is now unproductive since the Eunice King Well No. 24 is now being utilized as a salt water disposal well (Division Administrative Order SWD-550).

By authority granted me under the provisions of Rule 4(b) of the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Blinebry Oil and Gas Pool", as promulgated by Division Order No. R-8170, as amended, the following described 40-acre gas spacing and proration unit to be dedicated to said Eunice King Well 19 is hereby approved:



Reference is made to your application dated November 9, 1990 for a 120-acre non-standard gas proration unit consisting of the following acreage in the Blinebry Oil and Gas Pool:



It is my understanding that this unit is to be simultaneously dedicated to your Eunice King Well No. 19 located at a standard gas well location 660 feet from the North line and 1980 feet from the West line (Unit C) of said Section 28 and to the Eunice King Well No. 24 located at an unorthodox gas well location 2086 feet from the North line and 760 feet from the West line (Unit E) of said Section 28.

By the authority granted me under the provisions of Rule 2(a)4, 2(c) and 4(b) of the Special Rules and Regulations for the Blinebry Oil and Gas Pool, as promulgated by Division Order No. R-8170, as amended, the above-described non-standard gas spacing and proration unit and unorthodox well location are hereby approved.

Further, Division Administrative Order NSP-1510, dated August 4, 1987, which granted a 40-acre non-standard gas spacing and proration unit comprising the SW/4 NW/4 (Unit E) of said Section 28 and had dedicated thereon the Eunice King Well No. 24, is hereby placed in abeyance until further notice.
