Amended Administrative Order NSP-1542

Dear Ms. Bradfield:

Reference is made to your application of March 13, 1989 to amend Administrative Order NSP-1542 dated September 14, 1988, to include provisions for a non-standard gas spacing and proration unit in the Basin-Fruitland Coal (Gas) Pool.

Under the provisions of Rule 6 of the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool, as promulgated by Division Order No. R-8768, said Administrative Order NSP-1542 is hereby amended and the following described 223.44 acre non-standard gas spacing and proration unit in said pool is hereby approved.

SAN JUAN COUNTY, NEW MEXICO
TOWNSHIP 30 NORTH, RANGE 8 WEST, NMPM
Section 18: Lots 1 through 4, E/2 W/2

Said unit is to be dedicated to the Howell "C" Com Well No. 301 to be drilled at an unorthodox coal gas well location (previously authorized pursuant to Decretory Paragraph No. 4 of said Order No. R-8768) 1660 feet from the North line and 1320 feet from the West line (Unit F) of said Section 18.

All other provisions of Administrative Order NSP-1542 shall remain in full force and effect until further notice.
