Dear Mr. Newell:

Reference is made to your application dated March 18, 1993, for an unorthodox Jalmat gas well location in an existing non-standard 320-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising the S/2 of Section 10, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order NSP-1544, dated September 27, 1988 and had dedicated thereon the H. S. Record WN Well No. 1 located in Unit P of said Section 10.

By Division Order SD-91-1, the H. S. Record WN Well No. 6 was recompleted to the subject GPU from the South Eunice Seven Rivers Queen Pool and located at a standard location 1980 feet from the South line and 2055 feet from the East line (Unit P) of said Section 10.

By Division Order NSL-3205(SD), dated December 4, 1992, an additional well, the H.S. Record "WN" Well No. 2 located in Unit M at an unorthodox gas well location 560 feet from the South line and 660 feet from the West line of said Section 10, was included in the 320-acre Jalmat spacing unit.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170 as amended, the following described well, to be recompleted from the South Eunice-Seven Rivers-Queen Pool and located at an unorthodox gas well location is hereby approved:

*H.S. Record WN Well No. 3
1980' FSL - 660' FWL (Unit L) of said Section 10.*



Dear Mr. Renfro:

Per your letter dated April 2, 1991, you are hereby authorized to simultaneously dedicate Jalmat Gas Pool production to the previously approved non-standard 320-acre gas spacing and proration unit comprising the S/2 of Section 10, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico (Division Administrative Order NSP-1544, dated September 27, 1988), from the existing H.S. Record "WN" Well No. 1 located at a standard gas well location 990 feet from the South and East lines (Unit P) of said Section 10 and to your H.S. Record "WN" Well No. 6 located at a standard gas well location 1980 feet from the South line and 2055 feet from the East line (Unit J) of said Section 10. It is my understanding that the No. 6 well is currently completed in the South Eunice Seven Rivers Queen Pool as a producing oil well and will be properly plugged back and recompleted up-hole into the Jalmat Gas Pool upon issuance of this order.

Further, you are hereby permitted to produce the allowable assigned said 320-acre unit from both wells in any proportion.
