Gentlemen:

George H. Mitchell, whose address is P. O. Box 50682, Midland, Texas 79710, hereby respectfully requests administrative approval of a 23.13 acre oil proration unit for his proposed Littlefield B0 Federal well No. 5, Brushy Draw Delaware pool, to be located in Lot 11, Section 34, T.26 S., R.29 E., Eddy County, New Mexico.

The well location is, as shown on the attached Exhibit "A" (Form C-102 as filed with the Application for Permit to Drill), 1610 feet from the north line and 1650 feet from the east line of Section 34, which is also at a regular well location 330 feet from the north and east lines of Lot 11.

This well is a proposed 5200 foot Delaware oil test on Federal oil and gas lease LC-065928-A and Lot 11, comprising 23.13 acres, is to be dedicated to the well.

As shown on Exhibit "B", all of Section 34, except Lot 12, is included in lease LC-065928-A which is owned and operated by George H. Mitchell. The operator of the oil well in Lot 12 (lease NM-47159) is Ralph E. Williamson, whose address is P. O. Box 994, Midland, Texas 79702. Mr. Williamson is being furnished a copy of this application by certified mail and is being asked to furnish a waiver of objection.





