Dear Mr. Correa:

Reference is made to your application dated September 28, 1995 for an 80-acre non-standard gas spacing and proration unit ("GPU") consisting of the following acreage in the Blinebry Oil and Gas Pool:

LEA COUNTY, NEW MEXICO
TOWNSHIP 22 SOUTH, RANGE 37 EAST, NMPM
Section 9: N/2 SW/4

It is my understanding that this unit is to be dedicated to your existing J. L. Greenwood Well No. 13 (API No. 30-025-10134), located at a standard gas well location 1980 feet from the South line and 990 feet from the West line (Unit L) of said Section 9.

By authority granted me under the provisions of Rule 4(b)2 of the "*Special Rules and Regulations for the Blinebry Oil and Gas Pool*" as promulgated by Division Order No. R-8170, as amended, the above-described 80-acre non-standard gas spacing and proration unit is hereby approved. Also, you are hereby permitted to produce the allowable assigned the subject GPU, in accordance with Rule 5 of said pool rules based upon a unit size of 80 acres.

Division Administrative Order NSP-1620, dated January 28, 1991, which authorized a 120-acre non-standard gas spacing and proration unit comprising the N/2 SW/4 and SW/4 SW/4 of said Section 9 for the J. L. Greenwood Well No. 13 continues to be in abeyance until further notice. Also, Division Administrative Order NSL-3332(SD), dated November 16, 1993, which



authorized the unorthodox location of the J. L. Greenwood well No. 16 (API No. 30-025-30455), located 922 feet from the South line and 2238 feet from the West line (Unit N) of said Section 9 and the simultaneous dedication of both the J. L. Greenwood Well Nos. 13 and 16 to a standard 160-acre gas spacing and proration unit for the Blinebry Gas Pool, shall be placed in abeyance until further notice.

Dear Mr. Correa:

Reference is made to your application dated October 5, 1993 to reactivate a previously existing 160-acre gas spacing and proration unit in the Blinebry Oil and Gas Pool comprising the SW/4 of Section 9, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, and simultaneously dedicate to it the J.L. Greenwood Well No. 13, located at a standard gas well location 1980 feet from the South line and 990 feet from the West line (Unit L) of said Section 9 and the J.L. Greenwood Well No. 16, located at an unorthodox gas well location 922 feet from the South line and 2238 feet from the West line (Unit N) of said Section 9.

It is our understanding that the J.L. Greenwood Well No. 16 had originally been drilled in 1988 at a standard oil well location in the Brunson-Ellenburger Pool and that this well is currently producing in the deeper oil-producing interval of the Blinebry Pool. It is our understanding that upon issuance of this order, this well will be recompleted up-hole in the gas-producing horizons of the Blinebry Pool.

By authority granted me under the provisions of General Rule 2(c) of the Special Rules and Regulations for the Blinebry Oil and Gas Pool, as promulgated by Division Order No. R-8170, as amended, the above-described unorthodox gas well location for the J.L. Greenwood Well No. 16 is hereby approved.

Also, you are hereby authorized to simultaneously dedicate Blinebry gas production from the J.L. Greenwood Well No. 13 with the J.L. Greenwood Well No. 16. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from both of said wells in any proportion.


