Gentlemen:

Chevron U.S.A. Inc. respectfully requests administrative approval to amend Administrative Order No. NSP-1621(NSL) reducing the 80 acre non-standard Blinebry Gas proration unit to a 40 acre non-standard gas proration unit. The reason for the change is the recently recompleted Eunice King well no. 8 as a Blinebry Oil well. Well # 8 is located 1,980' FNL and 660' FEL (Unit H) of Section 28, T21S, R37E, Lea County, New Mexico. The proposed 40 acre unit will consist of the SE/4 NE/4 of Section 28, T21S, R37E. The Eunice King no. 13 well will continue to be dedicated to the proposed 40 acre unit. Well # 13 is located 554' FNL and 554' FEL (Unit A) of Section 28, T21S, R37E. In support of this application, Chevron U.S.A. Inc. states the following facts:

- 1) Administrative Order No. NSP-1621(NSL)(copy attached) dated January 30, 1991, approved an 80 acre non-standard gas proration unit in the Blinebry Oil and Gas Pool comprising of the E/2 NE/4 of Section 28, T21S, R37E, NMPM, Lea County, New Mexico, to be dedicated to the Eunice King # 13 in Unit A of Section 28.


- 2) Chevron's Eunice King well no. 8 located in Unit H of Section 28, T21S,R37E, has recently been completed as a Blinebry Oil well. This reduces the non-standard proration unit for Well No. 13 from 80 acres to 40 acres.

It is requested that 40 acres continue to be dedicated to the Eunice King No. 13. Attached is a plat outlining the proposed non-standard gas proration unit, and a map showing all offset properties and wells.

Chevron U.S.A. Inc. has mailed, by certified mail, a copy of this application to the offset Operators.


