Administrative Order NSP-1628-C

Dear Mr. Hartman:

Reference is made to the following: (i) your application submitted to the New Mexico Oil Conservation Division ("Division") on October 29, 2003 (*administrative application reference No. pMES0-330733619*); (ii) your telephone enquiry on March 10, 2004 checking on the status of this application; and (iii) the Division's records in Santa Fe, including the files on Division Administrative Orders NSP-210, NSP-1583, NSP-1598 (L), NSP-1628 (L) (SD), as corrected, NSP-1628-A (SD), and NSP-1628-B (SD) and Division Case No. 920, which resulted in Division Order No. R-693: all concerning your request for a non-standard 240-acre gas spacing unit comprising the following acreage in the Jalmat Gas Pool (79240):

LEA COUNTY, NEW MEXICO
TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM
Section 36: NE/4 and N/2 NW/4.

This unit is to be dedicated to Doyle Hartman's existing Arnott Ramsey "NCT-B" Well No. 3 (API No. 30-025-11863), located on a standard gas well location 660 feet from the North and East lines (Unit A) of Section 36.

Your application submitted on behalf of Arch has been duly filed under the provisions of the "Special Pool Rules for the Jalmat Gas Pool," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001.

By the authority granted me under the provisions of Rules 4 (C) and (D) of the special rules now governing the Jalmat Gas Pool, the above-described 240-acre non-standard gas spacing unit is hereby approved.

IT IS FURTHER ORDERED THAT Division Administrative Order NSP-1628-B (SD), which order established a 400-acre non-standard Jalmat gas spacing unit, comprising the NE/4, NE/4 NW/4, E/2 SW/4, N/2 SE/4 and SE/4 SE/4 of Section 32, for Doyle Hartman's Arnott Ramsay "NCT-B" Well No. 7 (API No. 30-025-26279), located 2310 feet from the South line and 990 feet from the West line (Unit I) of Section 32, is hereby placed in abeyance until further notice. This unit for all intents and purposes terminated in 1995 when the Arnott Ramsay "NCT-B" Well No. 7 ceased producing gas from the Jalmat Gas Pool.
