

Re: Bluitt San Andres Associated Pool
Roosevelt County, New Mexico

Gentlemen:

The following listed wells were originally drilled on standard locations for an oil well in the P₂ interval of the Bluitt San Andres Associated field. The Unit wells have been abandoned and recompleted in the non-unitized P₁ interval San Andres as gas wells.

Section 13 and Section 18 have been granted administrative approval for reduced proration units comprising one-hundred sixty (160) acres. At this time, Plains respectfully requests administrative approval for a reduced proration unit comprising one-hundred sixty (160) acres each be granted for the Bluitt 24 Federal #2 and the Bluitt 24 Federal #3 wells respectively and a reduced proration unit of eighty (80) acres be granted for the Bluitt 18 Federal #5 well.

Plains respectfully requests an allowable of 1280 MCFGPD be granted for each combined 160 acre proration unit comprising a total of 320 acres in Section 13 and Section 24 (see list below) and an allowable reduced by one-fourth (25%) be granted for the wells in Section 18, comprising 240 acres or a total of 960 MCFGPD, more specifically explained as follows:

Request an allowable of 1280 MCFGPD be granted for the North Half (N/2) of Section 13 to be shared by two wells (identified below) and not allocated 50% to each individual well.

- 1) Bluit 13 Federal #6 NW/4 (160 acres) of the N/2 of Sec. 13 (320 acres)
Bluit 13 Federal #1 NE/4 (160 acres) of the N/2 of Sec. 13 (320 acres)

Request an allowable of 1280 MCFGPD be granted for the North Half (N/2) of Section 24 to be shared by two wells (identified below) and not allocated 50% to each individual well.

- 2) Bluit 24 Federal #2 NE/4 (160 acres) of the N/2 of Sec. 24 (320 acres)
Bluit 24 Federal #3 NW/4 (160 acres) of the N/2 of Sec. 24 (320 acres)

Request an allowable equal to 75% of 1280 MCFGPD be granted to the two wells identified below in the W/2 of Section 18 with a total of 240 acres and not allocated to each individual well.

- 3) Bluit 18 Federal #11 SW/4 (160 acres) of Section 18
Bluit 18 Federal #5 W/2 of the NW/4 (80 acres) of Section 18

Plans are being finalized to recomplete the fourth well in the SW/4 (160 acres) of Section 13, the Bluit 13 Federal #11 and following successful recompletion of this well, an allowable for the S/2 (320 acres) will be requested.

I have enclosed a lease ownership plat and copies of Waiver letters mailed May 20, 1994 to all offset operators.




